Officer to put in a service request to help assist in informing Taswater.

5.4 Sewerage Smell

OD noted that there was a bad sewerage smell near Bridge Street and Esplanade

Officer noted that this is a complaint that should be directed to EPA

5.5 Campbell Town Transfer Station

Member noted that there is only 2 days for the CT transfer station. Tuesday and Sunday. The request was made for an additional day mid to end week. Request was made for a council coupon/ certificate or card for those that do not have household collection and go to the Transfer Station to dispose of their waste and every trip cost money.

Officer to investigate.

5.7 Valentine Park _ Aboriginal History acknowledgement _ Tyerrernotepanner People

Request from visitor through the Council website. This request should be forwarded to the Aboriginal community to have their say.

Officer to forward this request on to the appropriate body for consideration.

5.8 Working with Vulnerable People Card

Member expressed concern that there are volunteers that do not have a birth certificate only an extract nor a valid passport and will not be able to get a card without a huge expense and difficulty. There will be a huge risk of losing volunteers.

Request was made to ask for more information, would there be a discount? Will council pay for the fee? Officer to investigate and provide information.

5.9 CTDF Chair Resignation

JC stepped down as Chair. After moving into town almost 51 years ago, she has soon the town growing and moving with many new building applications. After successfully moving many projects along there was one project, she wanted to see completed: the footpath between Kind and High Street. She feels it is now time to step down and spend more time with family.
