With victim-survivor voices at the centre of the Governments approach, the five key elements of community consultation are:

- 1. Hearing Lived Experience Survey 2022
- 2. Establishing a Victim-Survivor Advisory Council
- 3. Targeted workshops with key stakeholders, including a focus on diverse communities and priority areas for action
- 4. Partnering with Tasmanian Aboriginal community-controlled organisations
- 5. Public written submissions



The Hearing Lived Experience Survey 2022 needs to hear from adults with lived experience of family and/or sexual violence, is currently open and will remain open, for 12 months. To take the survey: safefromviolence.tas.gov.au/

Public Attendance Council Meetings is being undertaken in accordance with the COVID-19 Disease Emergency (Miscellaneous Provisions) Act 2020 and is subject to he capacity limit o the meeting room.

While COVID-19 restrictions remain in place, Council is mindful of the need to ensure community safety and compliance about social distancing and limitations on the number of persons who may gather. This obligation is balanced with the need to minimise disruption to the business of Council.

From Monday 21 March 2022, limited public access to Council meetings is again permitted; however, public attendance is restricted to those who wish to make representation or present a statement in person at the meeting.

Preference will be given to individuals:

- making representations relating to planning applications which are subject to statutory timeframes (limit of 4 persons per item), and
- 2. those making statements or representations on items listed in the agenda for discussion (limited to 2 persons).

To ensure compliance with Council's COVID-19 Safety Plan, any person wishing to attend is required to register their interest to attend. Registration requests must be received by Council before 12noon, 4 days preceding the meeting (i.e., Friday 18 March) by emailing council@nmc.tas.gov.au or phoning Council on 6397 7303.

On arrival attendees will:

- be required to complete the health declaration section of their registration form; and
- receive direction from council officers (or Council's delegate) in relation to their access to the meeting room.

Public Question Time commences at 6.45pm however, access to the Municipal Building is only permitted prior to 5.00pm, and between 6.30pm to 6.40pm.

Alternatively, members of the public who cannot attend the meeting but would like to ask a question or make a representation to the Council, during Public Question Time, may forward their question/representation to council@nmc.tas.gov.au submissions must be received by Council before 12noon 4 days preceding the meeting (i.e. Friday 18 March). Any questions/representations received will be circulated to Councillors prior to the meeting, tabled at the meeting and recorded in the minutes of the meeting.

These arrangements are subject to review. Council will continue to ensure minutes and audio recordings of Council meetings are available on Council's website.

The Future of Local Government Review

The Tasmanian Government has commissioned the Local Government Board to undertake a Review of the role, function, and design of local government in Tasmania.

The review will look at:

The fundamentals of the local government system The role it should play in supporting communities The services it should be delivering, and The most effective ways of doing so.

At the end of the 18-month Review, the Board will make recommendations to the Government the reforms it believes are needed.

All Tasmanians will have an opportunity to have their voice heard, and more information about this will be published in the coming weeks including what opportunities for consultation will be available, both online and in your local area.
