The 2016 Census data showed the Northern Midlands Local Government Area had a population of 12,822 with 49.6% being male and 50.4% being female.

The 2021 Census data will be released from 28 June 2022, and it is estimated that the population of Northern Midlands will have increased to 13,852. That's an additional of 1030 people living in our communities.

This data is important because it is one of the tools Council uses when identifying community need and the level of service required to meet those needs when planning for growth, building capacity, ensuring economic sustainability within our communities.

The provision of infrastructure such as roads and buildings, open spaces (including parks and reserves), and services such as waste management, are identified in Council's Asset Management Plans, Policy & Strategy which can be found at:

Northern Midlands Council has completed many studies and masterplans, committing funding for initial work on many projects with benefits accruing to multiple stakeholders and extending beyond Council boundaries, however, many of these projects cannot be funded by Council alone and may need to be completed in stages over multiple financial years as funding becomes available.

Stormwater Asset Management

Council provides a stormwater network within town areas to drain the majority of properties, roads reservations and public open spaces and the network includes 90 kms total length of pipes and manholes, pits and grates, plus council-maintained water entry pits, pollutant traps, and detention storage facilities, with ongoing and staged operations and maintenance needs.

Sheepwash Creek runs through the northern section of Perth and forms part of the town's stormwater network draining into the South Esk River. It utilises a water sensitive urban design (WSUD) to make use of natural features to improve the quality of stormwater runoff between Edward and Phillips Streets in Perth.

The works included creek widening, removal of trees, removal of fencing, and construction of a walkway, mitigating flooding from Sheepwash Creek and protecting the adjacent properties from flooding and facilitating:

- Better management of the creek due to widening and a reduction in the embankment slopes,
- Better maintenance and improved safety for Council workers and the community

- Creation of a multi-functional and attractive open space for residents and visitors in west Perth, enhancing Perth's natural charm.
- Better quality water releasing less silt into the river system.





Stormwater System Flood & Risk Studies exist for all urban areas in the municipality with plans to provide Stormwater services for operation, maintenance, renewal, and upgrade of stormwater to meet service levels set by Council in annual budgets.

At the Council meeting to be held on 27 June 2022, Council will consider the 2022/2023 draft budget which includes submissions from local district committees and community groups. Council will strive to facilitate healthy communities with a strong sense of wellbeing through the development of community services and activities while continuing to lobby the Tasmanian Government, Australian Government, and private industry to deliver the projects and meet the aspirations of the communities delivering on its vision of Northern Midlands, being an enviable place to live, work and play.
