Future of Local Government Review Final Report Released

The Final Report about the Future of Local Government Review has now been released with the local Government Review Board (the Board) making 37 recommendations on how our

current system needs to change so councils can meet the challenges and opportunities our communities will face in the next 20-30 years.

In brief, the Report states that Councils face pressures beyond their control and clarifies that the problem is not with individual councils, but with the broader structure of the local government sector itself leading to limited options being available within the current system of local government to respond.

The proposed reform package aims to provide assurance that councils can improve the wellbeing of local communities by delivering against five core outcomes:

- Support healthy and sustainable local communities.
- Deliver better local services.
- Build and maintain future-ready community assets.
- Ensure local government represents you and your community; and
- Ensure local government represents you and your community.

The report acknowledges that, "Both Meander Valley Council and Northern Midlands Council oppose any change to their boundaries, and they appear to have significant community support for their positions. Northern Midlands Council has stated that if it were forced to amalgamate, it would prefer to merge with Meander Valley Council rather than other scenarios, because of its similar geography, demographics and community of interest, and a history of shared service arrangements".

In July 2023 both the Premier Jeremy Rockliff and Minister for Local Government, Nic Street, clarified the State Government's position, that there would be no forced amalgamations, however, the Board believes that to deliver on these outcomes, two main types of reform are needed:

Board Recommended Structural Reforms - councils need both greater scale and capability achieved through boundary consolidation, as well as greater capacity to work together and share resources.

Voluntary amalgamations are recommended, reducing the 29 councils to 15 acknowledging any changes would need to undergo a more detailed assessment and community vote before being implemented.

The Board also is recommending council designed, but mandated, participation in shared services arrangements, such as key technical professions where capability gaps are being felt the most.

Board Recommended Specific Reforms – improvements are needed to how councils are governed, funded, and deliver services. Councils need to operate within systems and frameworks that support them to be as efficient, effective, and accountable to their communities as possible.

Some of the recommendations included in the "Specific Reforms" are changes to the Local Government Act 1993 including:

- A renewed Strategic Planning and Reporting Framework,
- A statutory requirement for councils to consult with local communities to Identify wellbeing priorities, objectives, and outcomes.
- Rating and revenue changes within the context of a framework
- Elected member capability and conduct framework including ongoing professional development.



The Minister is now carrying out a final round of consultation with councils and the community until 29 February 2024 and there are several ways you can have your say.

Given the significance of the Report, Council will now take time to consider the 37 recommendations in full, with a final submission to be made in February 2024.



Northern Midlands Council, Footpath Program

In 2022/2023, Northern Midlands constructed/reconstructed 7026m² of footpaths at a cost of \$1.195 million: 4,952m² new concrete; 1,263m² new asphalt; 650m² replaced concrete; and 161m² replaced asphalt.

The 2023/2024 budget allocation is \$926,000 which is broken up as follows: Evandale Barclay St: From no 46 towards White Hills Road \$50,000 Western Junction Hobart Road: Off road shared path from Breadalbane in a northerly direction \$250,000 Perth Edward Street: Between Napoleon Street and Cromwell Street \$68,000 \$54,000 Frederick Street: Between Scone Street and Clarence Street \$40,000 Little Mulgrave Street: From Main Street to Unit development Longford Goderich Street: Between William Street and Archer Street \$22,000 Pakenham Street: Between Hobhouse Street and Bulwer Street \$60,000 Latour Street: From Lyttleton Street to Archer Street \$30,000 Latour Street: From Archer Street to Smith Street \$42,000 Cressv Main Street: Between Saundridge Road and Church Street \$75,000 Church Street: From Charles Street to Murfet Street \$25,000 **Campbell Town** Bridge Street: From High Street to Pedder Street \$15,000 Ross
