Northern Midlands Council Will Fight Merger Push

Northern Midlands Council has voted to fight any changes to its present boundaries or mergers with neighbouring councils.

Mayor Mary Knowles said it is Council's view Northern Midlands residents would be severely disadvantaged under all Community Catchment scenarios presented in the Future of Local Government Review.

- Under all scenarios proposed in the Review, Northern Midlands municipality would cease to exist in its current form.
- The Northern Midlands would lose its identity forever.
- Local services tailored to the community are at risk in bigger councils.
- Local representation would be weakened or lost entirely due to an increase in municipality size.
- Council is in a strong financial position and maintains its infrastructure to a high standard.
- No cost savings are expected from amalgamation.
- It has been acknowledged Council amalgamations fail to yield financial benefits.
- Rates for all residents would also likely rise following amalgamation.
