NORTHERN MIDLANDS 2025-2026 BUDGET

Focus on infrastructure and community investment

Northern Midlands Council has adopted a \$35.6 million Budget for the 2025–2026 financial year, with a continued commitment to delivering vital infrastructure and strengthening local communities.

The approved Budget includes a modest 5.5% general rates increase, alongside a 10% rise in kerbside waste collection charges. For the average residential property, this equates to an average increase of around \$110 per year, or just over \$2 per week.

The Budget balances essential services delivery with a strategic approach to long-term sustainability. It allows Council to continue upgrading infrastructure, meet growing demands on services, and maintain our commitment to community wellbeing. The Budget also addresses rising costs in materials, services, labour growth and asset depreciation.

Council will deliver an operating Budget with an underlying deficit of \$1.16 million, which it considers manageable and aims to reduce in coming years.

FIRE LEVY AND PENSIONER DISCOUNTS

The State Government's Fire Protection Levy will also increase this year. Northern Midlands Council will collect \$798,430 on behalf of the State Fire Commission — a 6% increase from last year. The minimum fire levy charge is \$50

Eligible pensioners may continue to access State Government rate discounts of up to 30%, capped at:

- \$566 for non-TasWater customers
- \$385 for TasWater customers

The concession applies to the principal place of residence as of 1 July 2025, and eligibility includes holders of a Pension Concession Card (PCC), Veterans Affairs Gold Card (TPP), or Health Care Card (HCC). Senior Card holders are not eligible.

Those who received a concession last year and remain eligible will see the rebate applied automatically. New applicants can apply online via www.nmc.tas.gov.au or by visiting the Council office.

Council is mindful of cost-of-living challenges and have worked to keep increases as modest as possible while still funding essential services and maintaining our assets for the

Ratepayers wishing to make special arrangements to pay their rates should contact the office prior to the 1st due date, however the making of arrangements does not preclude the charging of interest and penalty.

Northern Midlands Council resolved on Monday 7 July 2025 to make Rates and Charges for the period 1 July 2025 to 30 June 2026 under the Local Government Act (LGA) 1993.
