



PERTH MURAL PROJECT

BACKGROUND

- Late in 2018 Rosalie Wrigley, a Perth resident, approached Council with a proposal for a mural installation for Perth.
- The proposal is to paint a series of murals depicting Perth and its history and locate them throughout the town. With the impending by-pass of the town, the idea behind the proposal is to create attractions to draw visitors to the town.
- Council considered the proposal at its meeting of 18 February 2019 and made the following decision:
 - That Council supports the proposed mural installation in Perth and the following steps now be taken:
 - Council officers, in conjunction with Mrs Wrigley develop a draft implementation strategy for the project including:
 - A series of suitable locations for the murals;
 - Suggested images for the murals;
 - An implementation plan for the project.
 - The draft implementation strategy be referred to the Perth Local District Committee for comment;
 - The draft implementation strategy be advertised in the Northern Midlands Courier and on Council's Facebook page, inviting public comment.
 - Upon receipt of feedback from the Perth Local District Committee and the community a final implementation strategy be presented to Council for approval.

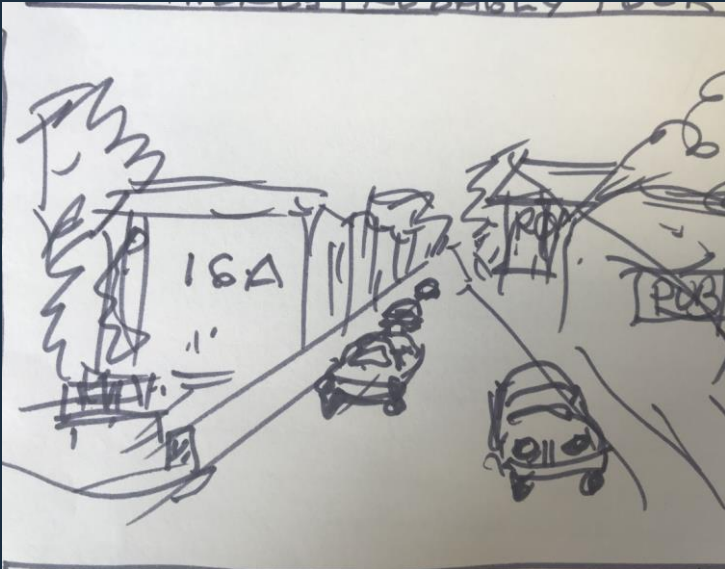

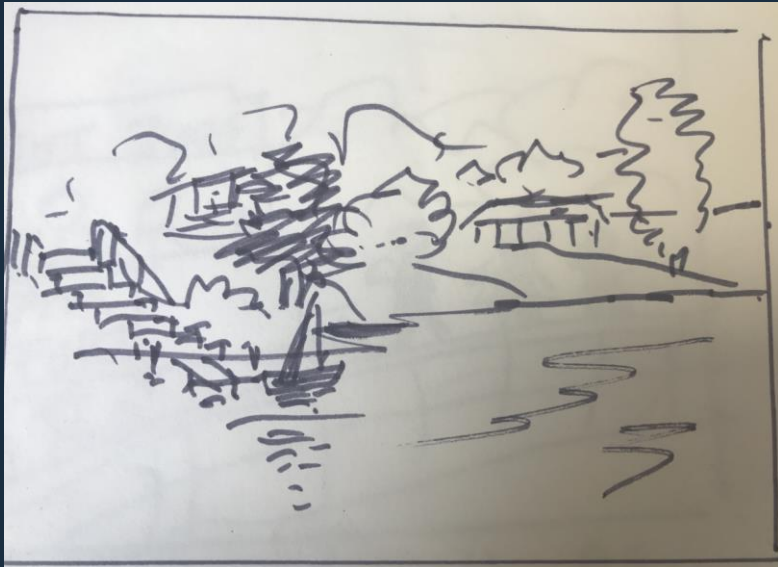
TRAIN PARK

- Council owned
- Proposed 2m x 1m freestanding mural on black powdercoated steel frame (2 sided)
- Planning approval not required provided 10m setback from all boundaries. Discretionary permit required if within the 10m setback.
- Will need to check for underground infrastructure
- Suggested theme for images:
 - Eskleigh & surrounds, Old fashioned maypole or carousel, Tabernacle, Bridge



SECCOMBE STREET WEST

- Council owned
- Proposed 2m x 1m freestanding mural on black powdercoated steel frame (1 sided)
- Planning approval required – discretionary application
- Will need to check for underground infrastructure
- Suggested theme for images:
 - Street scenes



William Street Reserve & Walkway

- Council owned
- Series of freestanding murals on black powdercoated steel frame (1 sided)
- Planning approval required – discretionary if within the flood prone area
- Will need to check for underground infrastructure
- Suggested theme for images:
 - Map of murals in town
 - River and picnic ground scenes

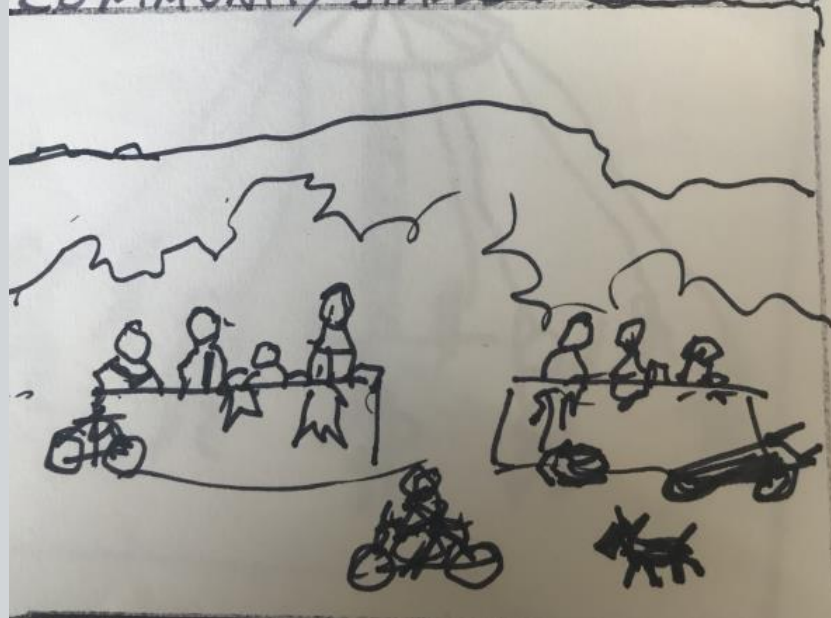

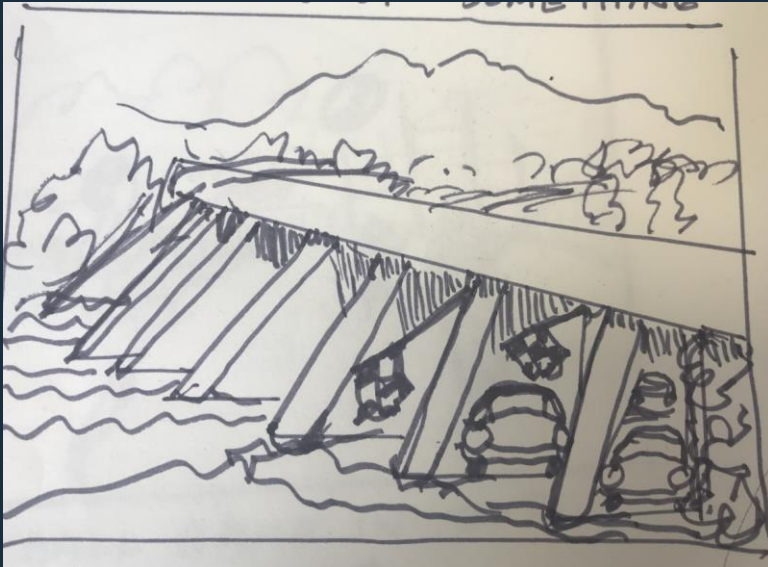


PERTH COMMUNITY CENTRE

- Council owned
- Proposed 2m x 1m mural attached to front and side of building
- Planning approval required – permitted, permit required provided setbacks met (5m front, 3m rear)
- No infrastructure issues
- Suggested theme for images:
 - Snapshots of local area (e.g. photo album open showing images of area), Community stalls and children

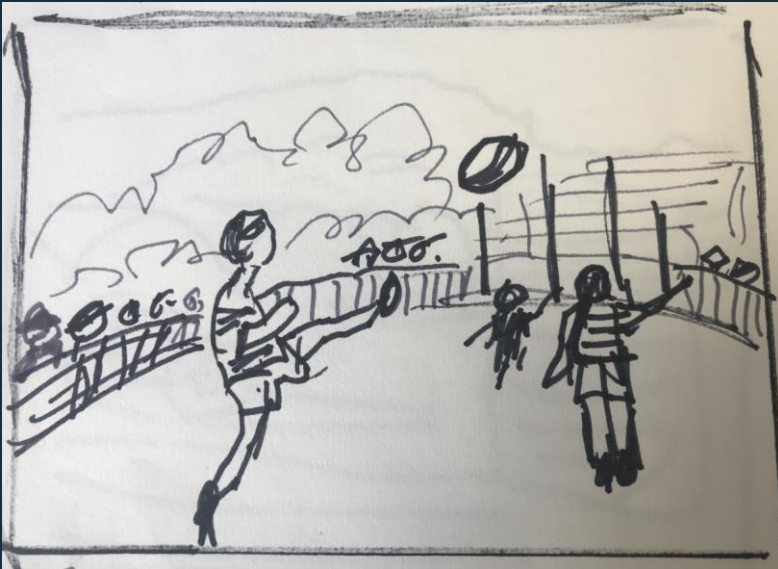


PERTH COMMUNITY CENTRE (WALL)



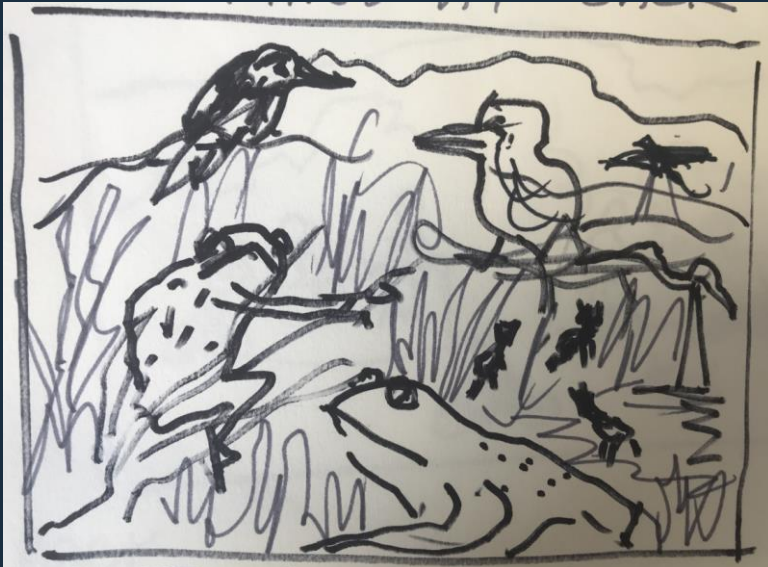
Perth Bridge pillars

- Not Council owned
- Approval from Department of State Growth required
- Proposed painting of pillars (up to 3m high)
- Planning approval not required
- No infrastructure issues
- Suggested theme for images:
 - Car racing series



Perth Recreation Ground

- Council owned
- Proposed 2m x 1m freestanding mural on black powdercoated steel frame (1 sided)
- Planning approval required – permitted, provided setbacks are met (10m from all boundaries)
- Will need to check for underground infrastructure
- Suggested theme for images:
 - Football game and spectator scenes



Youl Road

- Council owned
- Proposed 2m x 1m freestanding mural on black powdercoated steel frame (1 sided)
- Planning approval not required provided setbacks met and at least 50m from railway
- Will need to check for underground infrastructure
- Suggested theme for images:
 - Birds and frogs
 - Agricultural scenes



Mulgrave Street (dog off leash area)

- Council owned
- Proposed 2m x 1m freestanding mural on black powdercoated steel frame (2 sided)
- Planning approval required as within 50m from the railway
- Will need to check for underground infrastructure
- Suggested theme for images:
 - Dog running away from owner, General dog images



Seccombe Street Park

- Council owned
- Proposed 2m x 1m freestanding sign on black powdercoated steel frame (1 sided)
- Planning approval not required provided setbacks met (10m from all boundaries)
- Will need to check for underground infrastructure
- Suggested theme for images:
 - Landscape
 - Native animals

Implementation Strategy

Request budget from Council for installation of 4 murals per financial year until project complete

Confirm priority locations (Perth Local District Committee and community feedback)

Confirm themes/images for priority locations (Perth Local District Committee and community feedback)

Council officers to obtain relevant planning approvals

Mrs Wrigley and team to source paint and materials (at Council cost)

Mrs Wrigley and team to paint murals
